

**RE-ADVERTISEMENT AND TERMS & CONDITIONS FOR ENGAGEMENT OF TWO
(2) YOUNG PROFESSIONALS (IMPACT ASSESSMENT STUDY OF TIFAC
REPORTS) IN TIFAC(May, 2021) ON CONTARCT BASIS**

Technology Information, Forecasting & Assessment Council (TIFAC), an Autonomous Body under the Department of Science and Technology (DST), Government of India invites applications from Indian Nationals for engagement of two (2) Young Professional (Impact Assessment Study of TIFAC Reports) on full time contract and on consolidated remuneration (Professional fee) basis.

TIFAC has undertaken a study to assess the impact of TIFAC Reports (published in last 10 years) on the society, economic & technology growth of the country. TIFAC study reports cover about 20 broad sectors viz., Agriculture practices, Agri-chemicals, Agri-Livestock, Agri Biodiversity, Energy (Solar PV, Biomass, Biofuels etc.), Cyber Security, Electronics, Food Processing, Forestry, Materials & Natural Resources (Bauxite, Castor etc.), Manufacturing, Chemicals, Paper, Transportation, Electric Mobility, Medical & Health Care, Water, Environment, Climate Change & Disaster Management, etc.

TIFAC Study Reports are of various types: some are macro-focussed and others are micro-focussed. The impact could be assessed based on whether the study report facilitated in bringing out policy, product development, actions taken by other stakeholders or any other parameters as deem fit.

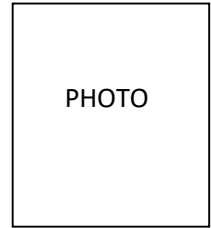
The Terms and Conditions of the engagement are as follows:

- 1. Name of position:** Young Professional
- 2. Number of positions:** Two (2)
- 3. Method of recruitment:** Through online advertisement and interview
- 4. Education qualification Essential:** B.E./or B.Tech/ or M.Sc.
- 5. Age:** Not exceeding 32 years as on 1st May, 2021
- 6. Scope of Work, Job Description and Responsibilities:** Desk research, Data analysis, literature search, report writing etc or any other related work may also be assigned as and when required.
- 7. Experience:** Minimum of one year post essential qualification experience in the areas scope of the work as mentioned above.
- 8. Other Attributes:** Candidates should have good working knowledge of technology based skills on the computer and ability to work on ICT applications. They should also possess strong communication and interpersonal skills. Candidates with M.Tech or MBA or Knowledge of Economics may be desirable.
- 9. Professional Fee / Consolidated Remuneration:** The Young Professional will be paid consolidated remuneration of Rs.60,000/- pm all inclusive and would include all taxes also (if any). No other incidental expenses viz. transport, telephone, etc. would be paid. In case he / she is deputed for outstation travel, he / she would be paid TA/DA/local transport equivalent to Pay Level-10 of 7th CPC.

- 10. Term of Contract:** The term of contract for Young Professional (Impact Assessment Study of TIFAC Reports) would be one year or co-terminus with project, whichever is earlier. The term of contract may be reduced at the discretion of TIFAC before making the offer of contract. After the contract is signed / accepted, TIFAC or Young Professional (Impact Assessment Study of TIFAC Reports) may terminate the contract by giving one month's notice in writing to the other party without assigning any reason. The term of contract may be extended beyond the duration mentioned above on the same rates and terms and conditions, if mutually agreed by both.
