Technology Information Forecasting and Assessment Council (TIFAC) an Autonomous Body under Department of Science & Technology, invites bids for auction of movable assets hypothecated to TIFAC and lying at M/s Clarisis Organics Pvt. 1. The property/ assets shall be sold on "**AS IS WHERE IS**" & "**WHAT IS THERE IS AND NON RECOURSE**" condition, including encumbrances, if any.
2. The interested purchaser(s) shall themselves satisfy about the right and title of the assets from the concerned authorities and no claim shall be entertained by the Authorized officer/ TIFAC in this regard after the auction of the properties.
3. All payments shall be made by Demand Draft drawn in favour of "**TIFAC**" payable at **NEW DELHI** or RTGS.
4. TIFAC reserves the right to postpone / cancel or vary the terms and conditions of auction any time without assigning any reason thereof.
5. No offers / bids below reserve price shall be entertained.
6. The Tender / auction will be conducted under the supervision of the Authorized Officer/Asset Disposal Committee of the TIFAC.
7. The Tender Form can be filled in the format as enclosed with the Tender document and supported with KYC documents specified therein.
8. The reserve price of the movable assets is Rs.14.39 lakhs.
9. Every bidders shall have to enclose an EMD of Rs.2,00,000/- (Rupees Two lakhs Only) in the form of a Demand Draft favoring TIFAC and payable at New Delhi alongwith Tender Form. Application form not accompanied by requisite EMD shall be deemed to be invalid and will be out rightly rejected by TIFAC.
10. The interested bidders should submit the sealed bids upto 1500 Hrs on 04.06.2019 addressed to the Incharge (Fin. & Admn.), TIFAC, Vishwakarma Bhawan, A-Wing, 1<sup>st</sup> Floor, Shaheed Jeet Singh Marg, New Delhi – 110 016. The envelope containing the bid should be subscribed "Offer / Bid for purchase of Plant and Machineries- Clarisis". Bids received after the prescribed time / date shall not be considered. The bids will be opened on the same day i.e 04.06.2019 at 1600 Hrs.
11. Buyers are requested to inspect the machines as per date and time fixed, before submitting their bid. The inspection can be done on 27.05.2019 (12.00PM to 5.00PM). Please note that no inspection is possible on any other date/time. After auction, TIFAC will not be responsible for physical condition of the items.
12. The Committee reserves all rights to accept or reject any offer without assigning any reason. In case of any issue, decision of the Committee / TIFAC will be final.
13. The EMD of the successful bidder H1 shall be retained in TIFAC. The highest bidder shall pay the balance amount within 05 days by Demand Draft (after deducting the EMD

amount) and the plant and machines will be handed over to them which will have to be shifted from the factory premises within 10 days after depositing the full amount without causing any damage to the factory building. In case the H1 fails to pay the balance amount in the stipulated time, its EMD amount would be forfeited and fresh bids will be done without any further correspondence.

14. The successful bidder has to remove the material within the prescribed period and if he failed a penalty of Rs.1000/- per day will be charged as rent for another 15 days. Even then, if the material is not lifted, entire amount deposited will be forfeited and fresh auction will be done without any further correspondence.
15. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the premises of the factory (M/s Clarisis Organics Pvt. Limited) and no delivery would be affected by this Office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.
16. Any tax liable shall be paid by the successful bidder only.
